# Oahu Outreach-Emergency Shelter Provider Meeting August 26<sup>th</sup>, 2021

# Changes to Isolation/Quarantine (ISOQ) Eligibility and Coverage (as of 8/26/21)

- → DOH continues to prioritize COVID+ individuals who live in congregate facilities (e.g. shelters, group homes, etc.) for ISOQ. Additional groups have been added in order of priority.
  - 1. COVID+ individuals who live in congregate facilities (e.g. shelters, group homes, etc.) and cannot safely isolate.
  - 2. COVID+ individuals who are being discharged from an acute care setting back to a congregate facility where they cannot safely isolate.
  - 3. COVID+ individuals who are being discharged from an acute care setting to an unsheltered setting.
  - 4. COVID+ individuals who do not have housing at all.
  - 5. COVID+ individuals who are living in overcrowded settings with other people who are at high-risk.
  - The significant reduction in available ISOQ beds (from 400 to around 60) has resulted in changes to the inclusion criteria to ensure that beds are assigned to individuals with the greatest risk of transmission to others.
  - Referrals are evaluated on a case-by-case basis, and particularly vulnerable individuals may still be able to receive a referral even if they are not congregate shelter residents.
  - Regardless of prioritization, providers should be aware that the surge in COVID-19 cases may result in a wait list for ISOQ beds, even for those who are in the priority groups.
  - ISOQ facilities do not include medical staff on-site to assist people with medical conditions or nursing care. Due to the physical structure of some of the existing facilities, individuals must be able to ambulate on their own and may need to be able to climb stairs.

## Call to Order/Success Stories

- Achieve Zero shared a recent success story involving a homeless veteran who had finally agreed to
  engage in outreach services. AZ was able to transition him to the HONU and facilitate a reconnection
  with the VA, who was able to provide a cell phone and assistance with VHA benefits. Finally, the
  veteran was able to be reconnected to his family after being estranged for the past 13 years, and was
  able to relocate to live near them.
- Kaimbrea at I.H.S. has been working with a woman with substance use issues who had lost custody of her two children. After receiving assistance with applying for public benefits and connecting to outpatient treatment, she was referred to a PSH program and, with the ongoing support from the I.H.S. outreach team and the Housing Navigator, she was finally able to move into an apartment this month. She is continuing to make progress toward her goal of reuniting with her children and establishing a successful co-parenting relationship, continuing outpatient treatment, and rejoining the work force.

- VA is continuing to participate in community outreach events to test and vaccinate homeless veterans. In addition to the events scheduled at Daybreak Church next Tuesday and Kakaako on 9/8, the VA is looking to set something up in Waikiki as well.

- The Emergency Housing Vouchers (EHV) through HPHA will begin next week. PIC is collecting EHV assessments from specific programs identified in the move-on strategy through HMIS.
  - 182 vouchers through HPHA will hopefully be filled by the end of the year.
  - 312 vouchers through the City & County of Honolulu will hopefully begin next spring, prioritizing youth and elderly households.
- Oahu Housing Now has housed 149 households so far.
- Oahu PIT Count is scheduled for the night of January 26<sup>th</sup>, 2022, but plans will depend on COVID-19 protocols.
- HUD CoC NOFO was released. PIC will send out information about the RFP process soon.

# → PIC Advisory Board draft template to assist with contact tracing and notification of COVID+ cases at shelters and encampments

- The purpose of this tool would be to streamline communication between CoC providers when COVID+ cases are identified at shelters, drop-in centers, or outreach locations.
- While each program should notify their funder of an outbreak at their facility, it is also important for other providers to know because so much interaction occurs between providers. Prompt notification

- will allow affected parties to take the appropriate steps to prevent the spread of COVID-19 among their own staff and clients.
- Using the template will be voluntary but would help to ensure that other providers receive the information they need in order to respond appropriately.
- The information would be sent to the PIC listserv. No names or other identifying information will be included.
- Please send feedback to Laura. The PIC Advisory Board will be reviewing the document next Thursday.

# → Solutions for COVID+ shelter guests who cannot or refuse to comply with on-site isolation protocols

- I.H.S. is seeking solutions for how to address a COVID+ guest who repeatedly violates isolation protocols. Due to a delay in ISOQ placement, the guest has been isolating in a separate room but often sneaks out of the room to smoke and talk to others and will not follow mask-wearing guidance.
  - To curb smoking, some providers suggested nicotine patches or allowing the guest to temporarily smoke indoors.
  - WCCHC suggested contacting the DOH investigator assigned to the case, or the DOH Standby
     Office at 586-4586, for suggestions or additional help.
  - Waianae Civic Center staff have been escorting COVID+ guests to their designated bathroom and smoking areas to ensure they are not mingling with others. While this can be effective, it is very taxing on staff.
