



HHHRC Syringe Exchange Program (SEP)

HHHRC exchanges sterile needles for used ones for people who use needles to inject drugs, steroids, hormones, or other substances.



2020 was another record year of syringe exchange, with 1,182,624 syringes exchanged statewide!





In 2020, statewide, the <u># of visits</u> (N=9,138) decreased 26% compared to 2019 (N=12,337).

Heaviest volume: July (919 visits)


Lightest volume: November (622 visits)


In 2020, statewide, the average # of syringes exchanged (N=129) increased 34% compared to 2019 (N=96).

Heaviest volume: September (106,255 syringes)

Lightest volume: March (86,442 syringes)









Gatekeeping Activity on the Rise in 2020

Out of 9,138 SEP visits, 3,432 unique individuals were identified using Participant IDs.


Of those 3,432 unique individuals, 25% (n=850) reported exchanging 799,156 syringes for 3,414 individuals!






Between 2016 and 2021, HHHRC trained <u>1,318 individuals to</u> administer naloxone.

- In 2021, HHHRC trained <u>114</u> individuals to administer naloxone.


Naloxone Registration Forms: Substances Used in the Past 30 Days – Jan to Jun 2021



Naloxone Registration Forms: Drugs Used in the Past 30 Days – Jul to Dec 2021




SEP Participant Registration Forms: Drugs Used in the Past 30 Days – 4/29/21 to 12/29/21 (N=130)
