State Homeless Emergency Grant (SHEG) – Increase in statewide funding.	SHEG provides one-time monetary assistance for housing, food, medical, and other types of expenses arising from emergency needs. This includes housing rental deposit and rent, utility costs and deposit, emergency medical care and expenses, transportation, and job-hunting expenses.	<p>Contract funding was increased by \$300,000 and was distributed among the following providers:</p> <ul style="list-style-type: none"> • Helping Hands Hawaii • Catholic Charities Hawaii
Housing Placement Program (HPP) – Increase in statewide funding.	HPP provides first month’s rent or security deposit, as well as temporary case management, for homeless families with moniro children.	<p>Contract funding was increased by \$500,000 and was distributed among the following providers:</p> <ul style="list-style-type: none"> • Catholic Charities Hawaii • Institute for Human Services • HOPE Services, Inc. • Family Life Center
Aloha United Way – Coordinated Statewide Homeless Initiative (CSHI)	CSHI provides increased emergency resources for Homelessness Prevention and Rapid Re-Housing statewide, and increases coordination for homeless services through the 2-1-1 Housing Coordination Center. The CSHI will also convene a consultant to make long-term strategy recommendations to address the needs of specific homeless sub-populations.	<p>Contract funding of \$5,000,000 was provided to Aloha United Way to implement a CSHI program in partnership with homeless service providers in all four counties.</p> <p>A total of 4,840 individuals (1,564 households) received assistance. Of this number, 63% were served on Oahu, 22% on Hawaii Island, 10% on Maui, and 5% on Kauai.</p> <p>The CSHI contract was also amended to provide short-term financial assistance to seven organizations who had recently experienced a reduction in federal funding from HUD. This short-term assistance prevented an estimated 300 individuals from falling into homelessness.</p>
Family Assessment Center	The Family Assessment Center will be located in Kakakao Makai and accommodate up to 60 persons at a time, or 240 persons over the course of a year.	The FAC opened in September 2016.
Emergency Rent Supplement Program	The Hawaii Public Housing Authority (HPHA) adopted emergency rules to establish a special Rent Supplement	The HPHA adopted emergency rules in June 2016, and selected Catholic

	Program to specifically target at least 100 homeless families. The program will provide ongoing shallow subsidies for low-income homeless families.	Charities Hawaii to implement the program effective July 2016.

431 Kuwili Street	Iwilei warehouse – former garment facility to be converted to permanent supportive housing with hygiene center and supportive services.	In 2019, the first floor of 431 Kuwili Street officially opened as the Punawai Rest Stop, providing hygiene center services for unsheltered homeless individuals in downtown Honolulu.
1506 Piikoi Street	Two vacant buildings formerly used as a school will be converted to 42 units of low-income housing for homeless households.	In April 2017, the City & County of Honolulu officially opened the facility at 1506 Piikoi Street.
85-248 Farrington Highway	The City will be installing 15-20 modular or container housing units for low-income homeless households.	In March 2018, the City & County of Honolulu officially opened the Kauhale Kamaile project at 85-248 Farrington Highway.
1055 River Street, Winston Hale	Existing commercial space will be repurposed/renovated into 6 micro-housing units for low-income homeless households.	In April 2017, the City & County of Honolulu held a blessing for the additional units at Winston Hale. In partnership with the State and the Hawaii Pathways Project, the City placed 30 chronically homeless individuals into units at Winston Hale and Pauahi Hale.
85-537 Halona Road	Existing derelict house on the property will be demolished. The City will install 3 modular units for low-income homeless households.	In October 2016, the City & County of Honolulu completed construction for the Halona Road modular homes.
Kahauiki Village TMK (1) 1-1-003: 204, 205, 206 , 207, 212	The City will lease the property to a nonprofit developer for the development and operation of 200+ single family and duplex units for low-income homeless households.	The Kahauiki Village opened on January 2018 and completed Phase I of the project. Phase 2 is currently underway.

West Hawaii Permanent Supportive Housing Project	The County will construct a micro-unit project to provide permanent housing for 18-32 individuals, which will include a multi-purpose area for individual and group counseling. An on-site property manager will also maintain the facilities, and coordinate wraparound social services.	The County of Hawaii opened Hale Kikaha in November 2016, which provides permanent supportive housing units for chronically homeless individuals in West Hawaii.
