Discussion and Provider Updates

→ City & County of Honolulu Home Iso/Q Food and Services Program (see attached handout)

- The City's new Home Iso/Q Food and Services Program provides food/essential item delivery and wraparound services to COVID+ households who are isolating or quarantining at home and lack the resources to obtain their own food or essential items. This includes unsheltered people who are isolating in their encampment.
- The program is currently only taking referrals from FQHCs, DOH contact tracers, and homeless service providers. Homeless service providers would apply on behalf of their clients and make arrangements with the City's vendor, St. Francis, to coordinate the food box delivery.

→ HPD D1 CPT Chinatown Night Outreach Schedule

→ DHS Processing Center Updates (see attached handout)

- DHS Processing Centers (SNAP, GA, TANF) have been experiencing a high call volume, especially now
 that recertifications and phone interviews are being conducted. Some providers have reached out
 because their clients are having a hard time getting through to the Processing Centers, especially if
 they do not have regular access to a phone.
- DHS has shared a list of the email addresses for each of the Processing Centers in an effort to assist providers and clients.

- DHS suggests using a standard subject line such as "Contact on Client's Behalf" or something similar so staff can easily identify the email.
 - If a provider is contacting DHS on a client's behalf, DHS will attempt to reach out to the client
 - If a provider is requesting information from DHS about a client or to relay a message to the client, they are encouraged to include a copy of the signed DHS consent form:

→ Youth-Focused Programs (see attached handout)

- DOE YES outreach and Homeless Liaisons
 - DOE's main motivation is to provide children with educational stability.
 - YES outreach continues and liaisons are in the community more often. They are engaging
 with families who are keeping their kids home from school and helping to connect them to
 needed supports.
- GCH student intern project re: minors and consent to services
 - GCH's Social Work practicum students are working on research related to different services that unaccompanied minors may access or receive, such as medical care, shelter, education, and more.
- Guide on the Side (GotS) Programs HHHRC, RYSE, and Hale Kipa
 - GotS is a program type that is currently funded through YHDP. The program intends to connect unsheltered young people 18-24 to services and programs that help them achieve their goals, and is not restricted to just housing.
 - Each agency has a specialty:
 - HHHRC's primary target population is LGB&T youth.
 - RYSE collaborates with We Are Oceania, Partners in Development, and Kupa Aina to help build capacity for culturally competent services that reflect the population RYSE is seeing on the streets.
 - Hale Kipa collaborates with Waikiki Health and Epic Ohana to enhance services for youth who are beginning to "age out" of youth-specific programs, focusing especially on youth aging out of foster care and pregnant/parenting youth.

Government/Funder Updates

- RYSE
 - The shelter has some openings for females, but there is still a waitlist for male beds.
 - RYSE is also seeking insights from anyone on the ability for unaccompanied minors to consent to vaccinations.
